TENANT(S) RESPONSIBILITIES

A sublease does not relieve any of the tenants or cosigners from the covenants of the lease and all parties will be held responsible for the actions of the subtenant while they occupy the premises. Oxford does not and will not have a formal agreement with the subtenant. Consequently, the landlord will seek remedy through the original tenant(s) and cosigners for damages, unpaid rent, and/or lease violations.

LANDLORD REQUIREMENTS FOR SUBLETTING APPROVAL

1. All original tenants must read and sign this document.
2. All sublease agreements shall be in writing with copies provided to Oxford **in advance**.
3. The subtenant must fill out an application **in advance**.
4. The subtenant must have a sample copy of the original lease and abide by the covenants of that lease **at all times**.
